The undersigned hereby agree(s) that in the event of any default by Debtor, Creditor shall be entitled to proceed against the undersigned immediately for such payment without prior demand to notice.

This Agreement shall insure to the benefit of Creditor, its successors and assigns, and the assignees of any Liabilities hereby guaranteed. **TERMS AND CONDITIONS**

The person on entity set forth on the reverse side of this application. “Applicant” hereby applies to Fantis Foods, Inc. To open a commercial charge account in Applicant’s name and hereby request Fantis Foods, Inc. from time to time to extend credit to enable Applicant to purchase merchandise from Frantis, Inc. for business or commercial purposes only. As an inducement to Fantis Foods, Inc. to extend credit, and in consideration of Fantis Foods, Inc. agreeing to extend credit to Applicant, Applicant states as follows: Applicant represents and warrants that (a) all credit information given in connection with this Application and Agreement (“ Agreement”) is true and correct as of the date hereof, and (b) it is financially able to comply with all payment terms specified herein or in any invoice form Fantis Foods, Inc. (“Payment Terms”), such as representation and warranty shall be deemed remade each time Applicant accepts credit from Fantis Foods, Inc.

If applicant wishes to return any products, applicant shall be responsible for any and all freight charges.

If any amount due for any merchandise remains unpaid on the last business date of the month in which payment was due, applicant should pay to Fantis Foods, Inc. a finance charge equal to 1 1/2 percent per month (18% A.P.R) on all past due amounts from the first day of the month immediately following the month in which payment was due, until such amounts are paid in full.

If Applicant pays any invoice with a check and the check is returned from Applicant’s bank unpaid for any reason, applicant will pay service charge of \$25.00 or one – half of one percent (1/2%) of the face amount of the check, whichever is greater. The service charge will be in addition to any finance charges that may be applicable.

The agreement shall be a continuing agreement and shall apply to each purchase of merchandise for which Applicant does not pay in full at the time of delivery. Applicant agrees that Fantis Foods, Inc. can change or amend any of the terms of this Agreement by sending written notice of the change to Applicant thirty (30) days before such amendment or change. Applicant’s continued use of this commercial charge account after the effective date of the amendment or change shall be deemed acceptance of the changed terms. Fantis Foods, Inc. may terminate this agreement or restrict or withhold deliveries to Applicant at any time without notice. Applicant will pay all expenses, including reasonable attorney’s fees, incurred by Fantis Foods, Inc. in the enforcement of this Agreement and the collection of any charges due hereunder. Applicant agrees to be governed by the laws of the State of New Jersey and consent to the jurisdiction of the courts of New Jersey.
